Guest Speaker: Pam O'Callahan from Sun Management

- Ryan has left Lemon Wood and they are looking for a replacement. Tibo is still on staff.
 - Since they are short one person, please be patient with maintenance requests.
- An outside vendor has been hired to maintain the pool (not including the deck):
 - Tuesdays and Fridays are scheduled for pool cleaning, subject to change.
- The pool is scheduled to be replastered in 2025 or 2026, with no pass-through for homeowners. The sauna has been replastered already. Resurfacing is recommended every 12 to 13 years.
- Gutters: Please contact the office about specific street gutters that require cleaning.
- Street paving: The slurry that was previously applied poorly is being replaced, one section at a time, but there is no firm schedule.
- Road signs: No additions are planned beyond the signs that were recently installed.
- Report speeders to management (company name, truck number and/or license plate numbers are helpful).
- The roof was leaking in the two game rooms due to heavy rains last year. The flashing was identified as the culprit and has been sealed. The ceilings have been repaired.
- Water was seeping from an exterior planter into the social committee's storage area. The leak has been fixed.
- Adding Cornhole to the Bocce Ball Court:
 - Pam agrees that this is a "very cost-effective suggestion."
 - Residents will be polled.
 - \circ A question was raised about where to store the equipment when it's not in use.
- The old trash receptacles will probably be removed. Other suggestions are murals, storage units and seating.
- Additional benches may be added throughout Lemon Wood.
- Operational issues with the entrance gate on Johnson were discussed.
- Solar awning lights are on timers and the solar company will need to address any issues.

New Business:

- John O'Neal (Recycling):
 - Wine bottles are heavy and the pay-off is small, so they will no longer be collected:
 - \$1.70 per pound of aluminum and \$1.30 per pound of plastic vs. 10 cents per pound of glass.
 - Other types of glass bottles will still be accepted, e.g., beer, water and soda.
 - Harrison will recycle wine bottles if you put them in your recycling bin, or you can redeem them yourself for 3 cents per bottle.
 - Please crush your plastic bottles if possible.
 - Bottle caps can be left on or off.
